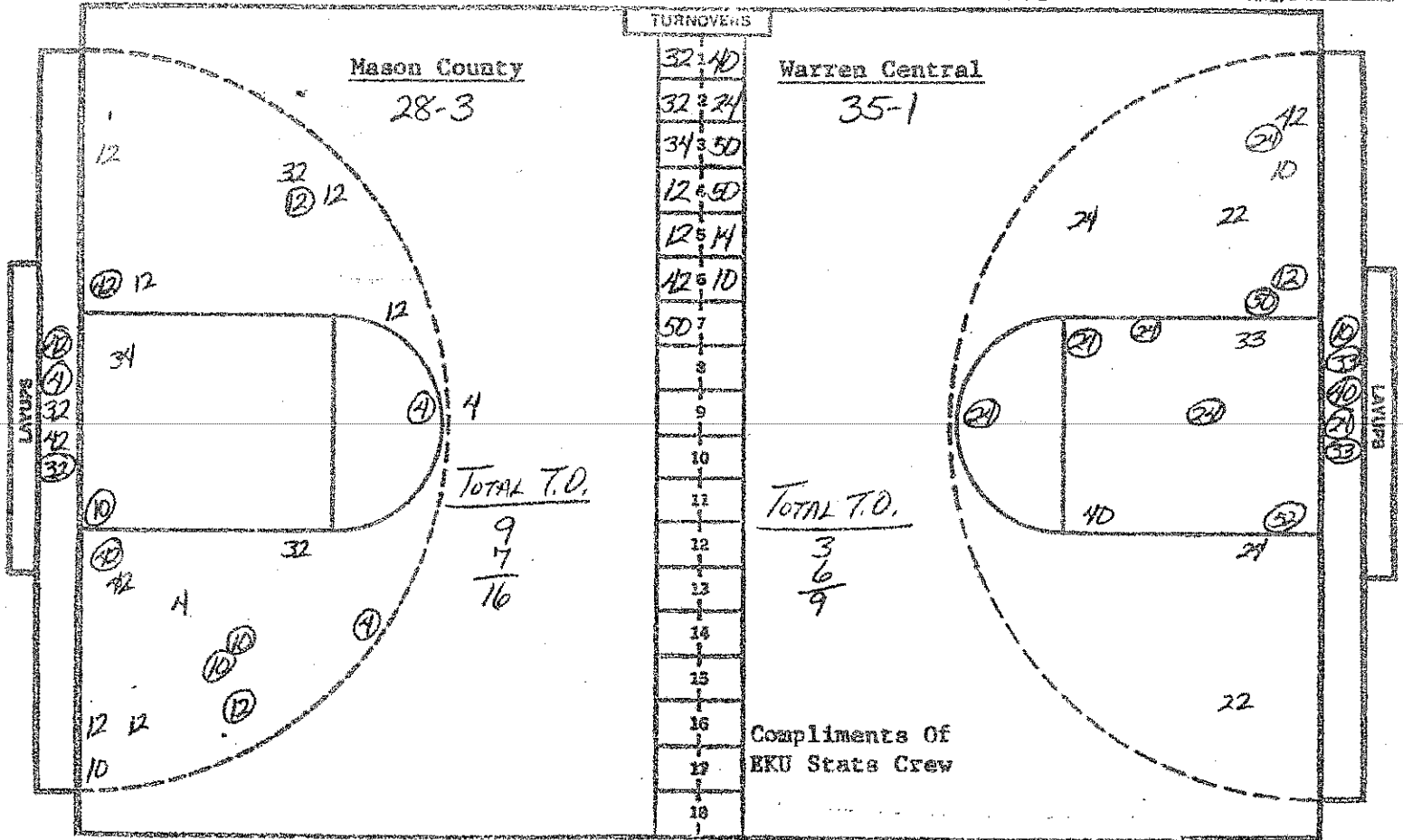
CAGE CHART
