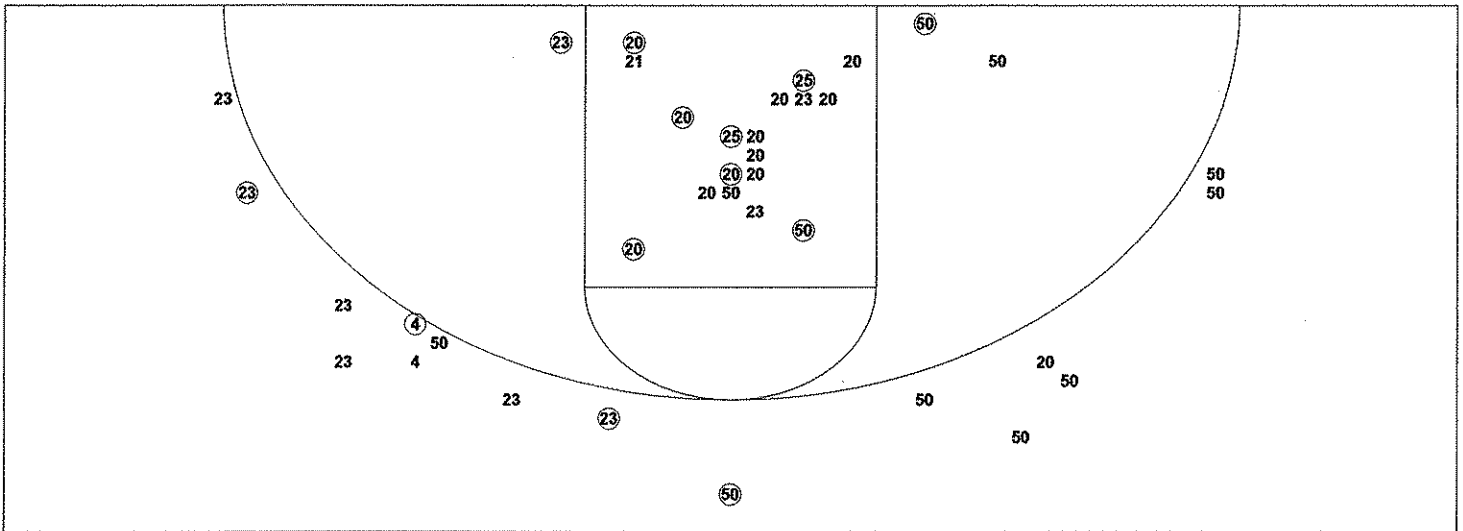

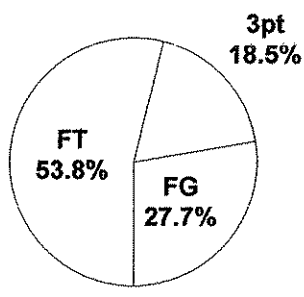

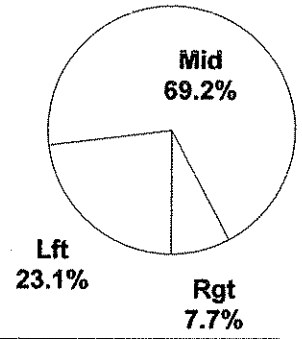

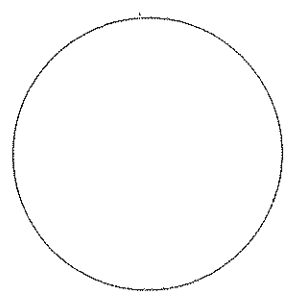


Scoring Locations
