	Pole Vault
Landing Pad 19' 8" wide 20' 2 deep 16'5 back of box Runway 130'	Landing pad meets all National Federation regulations. Runway is in need of repair. I canceled the event at the Henry County Wildcat Relays for the fact that the last 10 feet of runway was extremely rough and actually has surface missing. I discussed with the Henry County coaches that this needed to be fixed before any pole vault competition or practice is allowed at this site. It appeared that a somewhat attempt had been made to fix it but the material used was as loose as sand on the runway.
Planting Box	Box is level with runway.
Standards/Crossbar 13'8 – 14'8" Bar 14'10"	Standards are in good shape and securely fastened to the ground.
Surrounding Area	No problems. Grass surrounds the pad.
Weigh In of Athletes	It is <u>highly</u> recommended that the Pole Vault Official have scales provided by the host school to weigh the Vaulters to assure that there weight is in compliance with what is listed on the vaulting pole.
Coaching Box	No coaching box needed vault is clearly visible from outside track area.
Pole Vault Venue	Once the runway is repaired, it is good to go.

	High Jump
Landing Pit 16' by 8'	Pit meets all National Federation requirements.
Standards/Crossbar 12' apart Bar – 12'	Saw no problems with standards or cross bars. Standards do need adaptors to go down to a lower height that is sometimes need for high school girls or middle school athletes.
Surrounding Area	There is some hard surfaces that are exposed should be covered for every meet. These hard and unyielding surfaces can present a liable situation to the school and they need to be addressed at each practice and meet.

Officials Overall view of this Track and Field Complex	Pole vault runway <u>HAS</u> to be fixed. High Jump needs hard and unyielding surfaces covered. Need flagging in the throwing event areas. Need more sand in the long/triple jump pits. All marking on track need to be repainted, really hard to see some of the exchange zone marks which is very unfair for the runners. Hurdle marks in bad shape. Track itself is showing wear. Rest of complex is in good working order. <u>Hurdles do need repaired</u> . To properly host the regional meet you will need 80 <u>complete</u> hurdles with a top board that is clearly visible for the athletes to see.
Regional Meet Site (In your opinion would you recommend this facility be considered as a Regional Meet Site. If No what would they need to do to bring this facility into compliance.	If pole vault runway and Hurdles are fixed site will be ok for Regionals. I am however concerned about who Is going to run the meet off. I know Henry County has a new coach this year. I met him when I arrived to the track and I didn't see him again until I was ready to leave. I had to constantly radio to the press box for such issues as getting hurdle put on track and moved and adjusted. Had no exchange zone judges. Had a 20 minute delay trying to get hurdle in place for the 300mh finally after several announcements several spectators and coaches came out
