# ANNUAL MEETING OF DELEGATES

The KHSAA Annual Meeting of Delegates is scheduled for next Thursday, Oct. 19 at the Lexington Convention Center. Twenty-one proposals will be voted on by the membership. Delegates will attend workshop sessions on technology, Title IX, coaching education and risk management beginning at 8:15 a.m. until 10:50 a.m.

A roundtable discussion on the proposals will be held from 11 a.m. until 12:30 p.m. in the Bluegrass Ballroom, with the voting session scheduled to begin at 1:30 p.m.

This is a reminder regarding the Annual Meeting voting and approval process:

- A two-thirds vote of the registered delegates in attendance is required for passage
- Following the Annual Meeting, the KHSAA Board of Control reviews approved proposals and forwards them to the Kentucky Board of Education with either a favorable or unfavorable recommendation for adoption
- The entire KHSAA Constitution and Bylaws, including approved proposals, are then reviewed by the Legislative Research Commission Regulation Review Committee for a final decision regarding approval or implementation
- KBE then recommends approval or lack of approval for inclusion through 702 KAR 7:065 for the following year

Voting results will be posted on the KHSAA website Thursday evening following the meeting.

#### WOODFORD COUNTY GIRLS' SOCCER TEAM REMOVED FROM POSTSEASON

The girls' soccer program at Woodford County High School has been removed from postseason play for violation of Bylaw 25 – Limitation of Seasons KHSAA Commissioner Brigid DeVries announced. The program exceeded the maximum number of games played (17).

The KHSAA Bylaw states that "a season will consist of a maximum of seventeen (17) games. A maximum of two (2) tournaments may be included in any manner other than counting each game played against the limit of seventeen (17) games. Single elimination tournaments in which every team in the tournament is finished playing upon their first loss are eligible to be counted as one game against the limit of seventeen (17) games. All other formats of tournaments are eligible to be counted as two games against the limit of seventeen (17) games. Any team playing more than four games in any one tournament shall have each additional game played over four counted against the limit of seventeen. Any game played over the limit of four in any one tournament shall be counted against the limit of seventeen (17) games."

In addition, KHSAA Case BL25-3 states that "a school exceeding the limitation of games / contests / meets shall be ineligible for postseason play per the provisions of Bylaw 25, Section 3. In order to allow consistent enforcement and adequate communication with managers and the verification of all facts involved, and to assist tournament managers once a tournament series has begun, the time of determination is established for all sports.

For the determination to be made that the limit has been exceeded, it must be reported in writing and received by the KHSAA prior to 12:01 a.m. (midnight) ET on the first day of the postseason tournament series as defined by the KHSAA Memorandum Calendar. If detected and verified, the team exceeding the limit would be ineligible for postseason play and may be further penalized in accordance with Bylaw 33. If the report is made after that point, the team shall be penalized in accordance with Bylaw 33 but shall remain eligible for tournament play during the current season."

Woodford County participated in 16 regular season contests and three games in the Lexington Catholic Lady Knights Soccer Cup to put its games total at 18 (the tournament counted as two games due to its format). Due to the violation, the girls' soccer program will not be permitted to participate in postseason play this year.

Woodford County was scheduled to play the winner of Monday's Frankfort vs. Western Hills contest in the Girls' 25<sup>th</sup> District Tournament. Since the bracket was already set once the violation was reported, the schedule will remain with the Frankfort-Western Hills winner advancing to the district championship on Thursday.

## CENTRAL HARDIN/COCHRAN REPEAT GOLF CHAMPIONSHIPS

Central Hardin girls' golf team and Case Cochran of St. Mary's boys' golf team repeated as team and individual champions at the 2006 Leachman Buick & GMC/KHSAA State Golf Championships held last week at Bowling Green Country Club.

Central Hardin (644) finished 25 shots ahead of second place West Jessamine (669) to win the girls' team title. Sacred Heart (675) finished third and Christian Academy-Louisville (682) finished fourth. Russellville's Nikki Koller won the individual title with a 146, one shot ahead of North Hardin's Lydia Gumm who fired a 147. Candice Wiley, last year's individual champion, finished sixth at 156.

Case Cochran became the first back-to-back boys' individual champion since George Stigger of Kentucky Military Institute won back-to-back champions in 1955-56. Cochran carded a four-under par 68 in the second round to finish twounder for the tournament at 142. Cameron Carrico of Owensboro Catholic also had a strong second round. Carrico was tied for 24<sup>th</sup> after the first round, but shot 70 on the second day to finish at 149 and tied Henry Clay's Kenny Goodykoontz for second.

Henry Clay took home the boys' team title with a 621. St. Mary, last year's team champion, was second at 623. Bowling Green was third at 635 and Heath was fourth at 642.
