KHSAA BOARD APPROVES DRAFT BUDGET/FOOTBALL ALIGNMENT/ELECTS OFFICERS

The Kentucky High School Athletic Association Board of Control approved a draft \$3.7 million dollar budget for fiscal year 2009, a draft football alignment for 2009 and 2010 and elected officers of the Board for 2008-2009 at its regular meeting Tuesday in Lexington.

"The Association is on sound financial ground thanks in large part to the outstanding support by our member schools, officials, fans and corporate sponsors," KHSAA Commissioner Brigid DeVries said.

The Board approved the Football Committee's recommendation to maintain the previously approved alignment for 2007 and 2008 along with some minor modifications on a case by case basis with regard to a great variance in travel and geography and changes in enrollment figures.

"The Board chose to move forward by tweaking the current alignment and make minor adjustments rather than starting over and aligning top to bottom or using other variable," KHSAA Assistant Commissioner Julian Tackett said. "With only one year into a new playoff system, there really wasn't enough data to make major revisions."
