### **FALL SPORTS SEASON IN FULL SWING THIS WEEK**

The fall sports season hits overdrive this week with the first date for boys' and girls' soccer matches on Monday, August 17 and the first date of football games Friday, Aug. 21. Golf enters its third week of play while volleyball begins its second week of action. The first date of cross country meets is Monday, August 24.

### **CLARIFICATION OF BYLAW 13**

In light of recent inaccurate information that has been disseminated regarding Bylaw 13 (Financial Aid), the following is a short clarification of the rule:

Bylaw 13 deals with financial aid. The best way to remember the rule is that any monetary aid awarded to a student is considered financial aid. There are two types of financial aid – Need Based Aid and Merit Awards. Need Based Aid is awarded based on the need index similar to a Financial Student Aid form a family may have to fill out when applying for financial aid in college. All schools must use one of the six approved neutral outside agencies listed in the KHSAA Handbook to determine a family's need index; it cannot be determined solely by school personnel. A student's Need Based Aid can never exceed the total amount of the need index. Merit Awards is financial aid based on a student's outstanding academic performance on a standardized test. Students can accept Merit Awards on the condition that it must be open to all students and it cannot exceed 25 percent of a student's tuition and fees. The rest of the tuition can be supplemented by Need Based aid. Both types of financial aid are legal within these limitations. Annual reporting is done by all schools and available to the KHSAA upon request. Bylaw 13 is listed in its entirety on the KHSAA website (<http://www.khsaa.org/handbook/bylaws/bylaw13.pdf>).
