# SPRING FOOTBALL PROPOSAL ADOPTED AT ANNUAL MEETING

Contingent on final approval through the regulatory review process, KHSAA member school representatives will have the opportunity to designate spring football practice dates after the proposal passed at the organization's Annual Meeting of delegates on Monday.

The earliest the proposal could take effect will be in the spring of 2012. According to the language of the proposal, which passed by a vote of 159 for, 40 against with 13 abstentions, school administrators have until December 15 to notify the KHSAA in writing of the dates it plans to conduct spring football practice. Schools may not conduct practice until the end of basketball season and the three-week practice window must not interfere with the state's achievement testing window. Currently schools may begin practice as soon as their team is eliminated from postseason basketball. An amendment to the proposal would cap the amount of practice time each day at two hours during the three-week window.

Other proposals passed at the Annual Meeting included eliminating tournament counting exceptions and adopting a game-for-game count in the sports of basketball and volleyball. The maximum number of games in basketball is 30 and 35 for volleyball.

A proposal to revise Bylaw 25 Limitation of Seasons to remove the automatic requirement of ineligibility for tournament play from the penalty for exceeding contest limits also passed by a vote of 202-9 with 1 abstention.

The proposals now move to the Board of Control for recommendation of adoption, rejection or amendment by the Kentucky Board of Education. If the measures win approval by KBE, it then moves to the Legislative Research Commission. It then must then receive final approval of the Administrative Regulation Review Subcommittee, a statutory committee of the Kentucky General Assembly, before it takes effect.
